Riding Club Policies and Regulations

- Club practices are scheduled in sequential 2 hour increments. Please arrive on time to get maximum benefit of your lesson. Student should arrive no earlier than 10 minutes before the lesson and be picked up on time. If you have other children with you who are not riding, please keep them within your direct control. They are not permitted to wander around the farm unattended.
- Proper riding attire must be worn with the horse at all times. Riding jeans, helmet, boots with a heel and smooth sole (no running shoes). If needed boots and helmets will be available to rent for \$2.00 a practice.

Lessons Fees and Payments

- A registration form and release waiver must be completed before a student can ride.
- Two Hour Club Practice -\$40.00 (with one of our horses)
- Two Hour Club Practice \$35.00 (with your OWN horse)
- One Hour Lessons \$30.00 or 4 lessons for \$115.00
- Attend Practices once a week or twice a week
- Guardian of the student is responsible for payment. Failure of payment is subject to be sent to collections along with a \$50 late fee for every month the payment is late.

Monthly Prepaid Lessons

- All regularly scheduled club Practices MUST be prepaid at the beginning of each month in order to hold your spot. If payment is not received by the first week of the month, we cannot guarantee your lesson spot will be held for you.
- If you chose to discontinue lessons once the month has started, no refunds will be given.
- If you can not make it because of an emergency or planned vacation please contact Courtney and let her know at the beginning of the month.

Cancellations

- Cancellations are accepted with a 24 hour notice. Cancellations of the day of a lesson will be accepted for emergency reasons only or weather conditions.
- All make up lessons must be rescheduled within 30 days of the missed lesson.
- Each student is permitted ONE make up lesson per month.
